

Premium ClibPDF Software License Agreement

(Version P-1.10, January 27, 2000)

1. Subject Matter

This is a license agreement between FastIO Systems, Inc. (hereinafter referred to as "Licensor") and _____ (hereinafter referred to as "Licensee") in which Licensor grants Licensee certain rights in the software, Premium ClibPDF, subject to the terms and conditions of this agreement.

2. Definitions

"Software" means the Premium ClibPDF software. Premium ClibPDF is a source code software package that adds enhanced capabilities to Standard ClibPDF that is publicly downloadable from the web site of FastIO Systems, Inc. Premium ClibPDF is owned by FastIO Systems, Inc., and is not publicly available. It is available under this license agreement only to registered licensees of Standard ClibPDF that is licensed under a separate agreement. Premium ClibPDF includes image import modules for TIFF and PDFIMG formats, usage examples, and utilities for converting image formats as well as documentation.

"Derivative Work" means work that is based on the Software and that, if prepared without permission of the Licensor, would constitute a copyright infringement.

3. Items Provided by Licensor

Licensor shall furnish Licensee the Premium ClibPDF Software, as described above, in computer-readable source code form.

4. License

A. Licensor grants to Licensee subject to the terms and conditions herein a worldwide non-exclusive license to use and modify the source code, and an unlimited right to use, execute, reproduce, sell, lease, or otherwise transfer copies of Derivative Works.

B. This agreement shall continue in perpetuity.

C. Licensor hereby reserves all rights in Software not specifically granted by this license agreement.

5. Payment

A. The fee for the licensed Software is US\$900, and Licensee agrees to pay this fee in U.S. Dollars upon execution of this agreement and delivery of the Software.

B. Licensee may, at Licensee's option, extend this license to cover future releases of the Premium ClibPDF software for an additional fee after two years from the date of this agreement or after paid updates of Premium ClibPDF thereafter. Licensee may request updates to Premium ClibPDF at no charge, when and if available, for two years from the date of this agreement or from the date of delivery of paid updates thereafter. Availability, schedule and pricing of updates to Premium ClibPDF is solely determined by Licensor, and Licensor is not obligated to release updates for Software.

6. Restrictions

Licensee hereby agrees not to resell or sublicense Derivative Works in the form of programming libraries or tools that allow purchaser or sublicensee to create new application software.

7. Non-Disclosure

Licensee hereby agrees that all parts of Software supplied by Licensor will be maintained in strict confidence. Licensee further agrees that it will limit the use of Software to its own authorized employees and any agents or contractors using Software in the performance of service for Licensee. Licensee has the right to duplicate or otherwise copy or reproduce Software in whole or in part for the purpose of providing emergency backup or archive copies. For any other purpose, Licensee agrees not to disclose, duplicate or otherwise copy or reproduce Software in whole or in part without the express written consent of Licensor.

8. Title

Licensor shall retain sole and exclusive ownership of the title and copyright on the Software.

9. Property Rights Indemnification

Licensee, at its expense, agrees to indemnify Licensor against any loss, damage, cost, or expense (including attorneys' fees) arising from a claim that the Software breaches patent rights based on United States patent number 4,558,302 (so called Unisys LZW patent).

10. Warranty

A. Licensor warrants that it has the legal right to grant Licensee the license as set out in this agreement.

B. Except for the foregoing section 10A, Licensor makes no other warranties and Licensor SPECIFICALLY DISCLAIMS ANY WARRANTIES CONCERNING THE SUFFICIENCY OF THE SOFTWARE, SOURCE CODE OR BINARY EXECUTABLES, ITS MERCHANTABILITY OR ITS FITNESS FOR ANY PURPOSE. LICENSOR SHALL NOT BE LIABLE FOR ANY INDIRECT, SPECIAL OR INCIDENTAL DAMAGES OR LOSS OF BUSINESS, LOSS OF PROFITS, PRODUCTION DOWNTIME OR SIMILAR CONSEQUENTIAL DAMAGES. ALL SOFTWARE, SOURCE CODE, AND EXECUTABLE

BINARIES DELIVERED UNDER THIS AGREEMENT SHALL BE DELIVERED "AS IS". IN NO EVENT, LICENSE FEE FOR Software SHALL BE REFUNDED. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, OR THE EXCLUSION OF IMPLIED WARRANTIES OR LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY MAY LAST, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO Licensee.

11. Assignment

Neither party may sell, transfer, assign, delegate, or subcontract any rights or obligations under this agreement without the prior written consent of the other party.

12. Termination

This Agreement may be terminated by Licensee upon thirty days written notice of cancellation. In no event, License fee shall be refunded due to termination of this Agreement. Licensor may terminate on thirty days written notice if Licensee fails to observe any term, condition or restriction hereof; provided however, that if Licensee cures its default within the thirty day period, such notice of default shall be rendered ineffective.

13. U.S. GOVERNMENT END USERS.

The Software is a "commercial item," as that term is defined in 48 C.F.R. 2.101 (Oct. 1995), consisting of "commercial computer software" and "commercial computer software documentation," as such terms are used in 48 C.F.R. 12.212 (Sept. 1995). Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202-1 through 227.7202-4 (June 1995), all U.S. Government End Users acquire the Program with only those rights set forth herein.

14. MISCELLANEOUS.

This License represents the complete agreement concerning subject matter hereof. If any provision of this License is held to be unenforceable, such provision shall be reformed only to the extent necessary to make it enforceable. This License shall be governed by California law provisions (except to the extent applicable law, if any, provides otherwise), excluding its conflict-of-law provisions. With respect to disputes in which at least one party is a citizen of, or an entity chartered or registered to do business in, the United States of America: (a) unless otherwise agreed in writing, all disputes relating to this License (excepting any dispute relating to intellectual property rights) shall be subject to final and binding arbitration, with the losing party paying all costs of arbitration; (b) any arbitration relating to this Agreement shall be held in Contra Costa County, California, under the auspices of JAMS/EndDispute; and (c) any litigation relating to this Agreement shall be subject to the jurisdiction of the Federal Courts of the Northern District of California, with venue lying in Contra Costa County, California, with the losing party responsible for costs, including without limitation, court costs and reasonable attorneys fees and expenses. The application of the United Nations Convention on Contracts for the International

Sale of Goods is expressly excluded. Any law or regulation which provides that the language of a contract shall be construed against the drafter shall not apply to this License.

13. RESPONSIBILITY FOR CLAIMS.

Licensee is responsible for damages arising, directly or indirectly, out of Licensee's utilization of rights under this License, based on the number of copies of the Program you made available, the revenues you received from utilizing such rights, and other relevant factors. Licensee agrees to work with affected parties to distribute responsibility on an equitable basis.
